
Thank You for Being Part of Our Community

Please share this information with the Board & Membership.

These are the Staging Areas that we discussed at DPR's presentation on Feb. 19th (at VPR). Craig recommended the West Lilac location for an Equestrian Staging area. It is only 1000 feet from Bonsall Community park, **on land owned by DPR**. Those present at the meeting had a chance to ask questions, and it was the general consensus that West Lilac would be a good location for a Staging area for us.

We will need letters (emails) of support. You suggested that VPR membership vote on this, so I am supplying the information on both sites to you & the Board. One letter can go to Jim Desmond and to DPR as both have asked for the Equestrian support of this plan. Email addresses are listed below. One letter of support from VPR would be great, please list the current membership on the letter, individual letters are also welcome. In Closing we have Jim Desmond's support. <u>Via Montellano site</u>: This site is not owned by DPR, it is owned by California Department of Transportation. Ownership would need to be transferred to DPR. **CalTrans hydroseeded this area with coastal sage this will create problems for DPR when or if they take ownership of this site.** It is Mitigation land. The site has loud traffic noise & is close to RT76. There may be a problem with run-off from the hill in the rainy season. **Hopefully sometime in the future this will become a 2nd staging area for us. At this point it is problematic. We need a site now, and the West Lilac site has the best chance of becoming an Equestrian Staging Area in our lifetime.**

<u>West Lilac site</u>: It is only 1000 feet from Bonsall Community Park, on land owned by DPR. (see photo blue pin in the location)

Location: West Lilac Staging Area (33°17'42.0"N 117°12'55.9"W). This site is on the same side of West Lilac Road as the Bonsall Community Park & ½ Mile from Ocean Breeze Ranch. (see photo below)

We think this is a great location close to the Bonsall Community Park. It has trail access without the need to cross the river. Currently there is a 5-mile loop on sandy trails. Several new miles of trail will be added in the near future. It is centrally located within the San Luis Rey River Park. It has a flat area above the surrounding grade with Shade trees.

EXCITING EXTREME COWBOY CHALLENGE COMING TO VPR! March 29-30, 2025

Craig Cameron's Extreme Cowboy Racing Association (EXCA) is an obstacle challenge where the horse and rider are judged as they maneuver over each obstacle. The course is timed, and an algorithm adds bonus points to the overall score. The goal is to complete the course quickly with good horsemanship. In March, the Pacific Coast Cowboy Challenge will be held at VPR and is sanctioned by EXCA. The courses will be in the main arena and spectator friendly. If you enjoy trail riding, obstacle courses, or want to test your skills, EXCA is great fun!

There are divisions for every skill level – from beginner rider (Novice) to the highest advanced amateur (Non-Pro). Based on age as of January 1, there are two divisions for youth: Young Guns, ages 7-11, and Youth, ages 12-17. Pro is a division exclusively for professionals. Amateurs can compete against professionals in Open. The only division based on the horse, not the rider's skill level, is Green Horse, which is for horses of any age. This is a developmental opportunity as once a horse is ridden in any other division they cannot return to Green Horse.

Unique to this event will be a "Give it a Try" class for any rider age 7 or older that has never competed in Extreme Cowboy Racing. EXCA membership is required to compete, but not for this introductory opportunity. The judges are offering a riding clinic on Friday March 28 during which time riders learn how the obstacles will be judged.

All proceeds associated with the race will go towards the venue rental and competitor payout. Volunteering is a great way to learn more about EXCA, while enjoying watching the competition. Opportunities include scribing for the judge, resetting the course, gate personnel, timers, runners, etc. Of course, we welcome sponsorship too!
